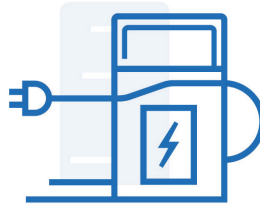
WHY SELL ELECTRIC?

BECOME A PARTICIPATING DEALER

Dealership Eligibility

TO ENROLL AS A PARTICIPATING DEALERSHIP, YOU MUST:

- Be licensed to sell vehicles in the state of Oregon
- Have a valid tax identification number
- Sell or lease an electric vehicle that is eligible for OCVRP

How to Become a Participating Dealer

Dealerships must meet the Dealership Eligibility criteria to enroll in OCVRP. Visit evrebate.oregon.gov to submit your enrollment form and accept the Terms and Conditions. In exchange for subtracting the cost of the rebate from the vehicle purchase amount, the Applicant will assign the rebate to the Participating Dealer. DEQ will then reimburse the dealer directly.

HOW TO PROVIDE "CASH ON THE HOOD"

TO PROVIDE REBATES AS "CASH ON THE HOOD," A PARTICIPATING DEALER MUST SUBMIT THE FOLLOWING WITHIN SIX (6) MONTHS OF THE PURCHASE OR LEASE DATE OF THE VEHICLE:

- A signed and completed Rebate Application form for each Applicant
- Proof of temporary or permanent Oregon vehicle registration
- Copy of the sales or lease contract
- Proof of Oregon residency (e.g., Oregon driver license)
- A signed Rebate Assignment Form

How to Become a Participating Dealer

New vehicles must have a base MSRP under \$50,000. Used vehicles must have an original base MSRP under \$50,000. Vehicles must be purchased or leased through a certified dealer or an original equipment manufacturer. No person-to-person sales are allowed.

ELIGIBLE VEHICLES

- New vehicles must have a base MSRP under \$50,000.
- Used vehicles must have an original base MSRP under \$50,000.
- Vehicles must be purchased or leased through a certified vehicle dealer or an original equipment manufacturer. No person-to-person sales are allowed.

VEHICLE ELIGIBILITY

INCOME ELIGIBILITY

No income requirement

Up to 120% of area median income (AMI)

Up to 400% of the federal poverty guideline

REBATE AMOUNT

\$750 for zero-emission motorcycles
\$1,500 for a battery under 10kWh
\$2,500 for a battery of 10kWh or more

STACK REBATES AND INCENTIVES

CUSTOMERS CAN COMBINE OCVRP REBATES WITH OTHER INCENTIVES!

- OCVRP Standard Rebate - Up to \$2,500 off.
- OCVRP Charge Ahead Rebate - \$5,000 off for low- to moderate-income Oregon drivers.
- Combine OCVRP Rebates - Up to \$7,500 off for low- to moderate-income Oregon drivers who combine the Standard and Charge Ahead Rebates!
- Federal Tax Credit - Deduct \$2,500 - \$7,500 depending upon tax liability and vehicle manufacturer.
- Utility Rebates - Utilities across Oregon offer rebates for EVs and installing charging stations.
